- Parents participate as a Co-oping Parent/Parent Helper in the class on a rotating basis, arriving earlier and staying late to support teacher and class.
- Co-oping duties include but are not limited to setting up and cleaning up the classroom; assisting the teacher and students; setting up bikes; cleaning off playgrounds; disinfecting and cleaning classrooms and bathrooms; vacuuming; and mopping. Co-oping is physically demanding. It regularly includes standing for long periods of time; kneeling and sitting on the floor; climbing up and down stairways; climbing up and down steep hills; and carrying heavy items. Parent co-ops also need to be able to clearly communicate with and be understood by children and adults. This includes communicating with emergency personnel should the need arise.
- Co-oping Parents/Adults must complete four (4) hours of Parent Education training over the course of the year according to state licensing requirements.
- Each family performs 8 required minimum community hours to the school **per semester** as well as attends one work party per year and participates/assists in our Online Auction(s) as detailed in the parent handbook.
- Fulfill all other obligations as outlined in Parent Handbook.
